After attending Ohio University and getting involved with both the Ohio Rural Health Association and the Heritage College of Osteopathic Medicine's Office of Rural and Underserved Programs, Megan has experienced firsthand the powerful role that organizations like these have in influencing rural health policy and preparing future physicians and leaders to practice in rural underserved areas. Rural health has become important to her throughout her involvement and through taking public health courses at Ohio University.

Legislative Committee

The legislative committee continues to meet monthly. Members of the committee continue to engage external stakeholders to ensure that we are aware of upcoming and current issues, as well as to identify opportunities for ORHA to lend our voice to issues pertinent to rural health in Ohio.

The ORHA Legislative Committee is tracking a grant opportunity announced May 4, 2021 from the U.S. Department of Health and Human Services (HHS) which announced an increase in the number of vaccines sent to rural communities as well as other initiatives related to underserved communities.

The announcement went on to describe that HRSA will support RHCs to increase the availability of COVID-19 vaccines in rural communities and expand outreach to build vaccine confidence. Working in partnership with the Centers for Disease Control and Prevention (CDC), HRSA is inviting Medicare-certified RHCs to join the new Rural Health Clinic COVID-19 Vaccine Distribution (RHCVD) Program to directly receive vaccines from the Biden Administration. HRSA and CDC will continue to enroll interested RHCs to receive COVID-19 vaccines, the allocation for which is separate from jurisdictions' weekly allocations.

In addition, through the Rural Health Clinic Vaccine Confidence (RHCVC) Program, HRSA will make nearly \$100 million available in grants to eligible RHCs nationwide to address health equity gaps by offering support and resources to medically underserved rural communities where COVID-19 vaccine uptake lags in comparison to more populated areas. HRSA will fund all eligible RHCs that apply. The RHCVC Program is the first targeted RHC grant since the passage of the Rural Health Clinic Service Act in 1977.

Health care workforce shortages that have plagued rural communities for decades have become exacerbated by the COVID-19 virus pandemic. Prior to the pandemic, 77% of rural counties were designated Health Professional Shortage Areas (HPSAs), and while approximately 20% or the nation's population live in rural areas, only 9% of US physicians practice in rural America.

This important bipartisan legislation would allow tens of thousands of nurses and physicians to join the firth against COVID-19 and address the significant health care workforce shortages in rural American by recapturing unused immigrant visas that congress has previously authorized and allocating those visas to international doctors and nurses who have trained in the United States. This could improve access to high quality health care services in rural communities and allow them to combat the COVID-19 pandemic and ultimately save lives.

HPERC: Engaging the Community in Rural Education

This presentation will seek to engage our colleagues from the perspectives of a rural medical educator, an AHEC leader, and a rural workforce specialist. Each presenter works with rural communities to develop and sustain quality educational experiences in rural communities. This team has also contributed to the development of a new research tool aimed at better understanding best practices and overcoming barriers to rural health professions education. A description of this project will provide early learning points from which we hope further discussion will ensue.

The Health Professions Education for Rural Communities (HPERC) Community Apgar Project allows communities to identify and weigh factors important in health professions education. Whether a rural community is new to having students or has had long standing success working with health professions schools, the new HPERC questionnaire and process is designed to provide a community with a differential diagnosis of modifiable factors for improving success. It is hoped that the research outcomes of this project will advance rural health professions education more broadly. The HPERC tool is based on a series of Community Apgar research projects intended to provide research outcomes while empowering rural communities to achieve rural workforce goals.

The 2020 County Health Rankings are available now

The University of Wisconsin Population Health Institute has been releasing annual county health assessment rankings since 2003. The assessments include more than 30 indicators that impact health. The program has grown from a few counties to a majority of the counties across the country. Since 2010, the Robert Wood Johnson Foundation and the Institute have been collaborating on this project.

The project assessments of population health are done with the intent of providing the framework for critical review of policies, systems, and environmental factors that can impact health. There is May 2021

also interest in using the assessments to help efforts that address health equity and health disparities, two central themes in this year's report. The report highlights strategies that work, provides step-by-step guidance on how to conduct community assessments, and shares stories based on real-life experiences.

Financial resources for businesses and families that have been impacted by Covid-19

The Small Business Relief Grant is designed to assist Ohio businesses that have been harmed by the effects of COVID-19. The \$125 million grant fund will provide relief to Ohio businesses that have been negatively impacted by COVID-19. Funding for the program is from the CARES Act. The business must be a for-profit entity with no more than 25 total or full-time equivalent Ohio employees as of Jan. 1, 2020. The applicant business has a physical location in Ohio and earns at least 90% of annual revenue from activities based in Ohio.
